E: General Public Comments

Mr. Keith Griffin voiced his concerns with funding for training for the Trustees when the Village is supposedly broke; he questioned the statement allegedly made by Trustee McMullan that the previous Board approved a rate increase for Aqua Water Company; he voiced his objection to the restricted use of 90 Town Center by certain individuals, and stated that the Mayor should stop talking about people in negative ways.

Village Manager Pate responded that the allocation for training for the Trustees was previously passed, and the agenda items tonight is to transfer \$500 from each Trustees' budget to the clerk's budget for training. Therefore, there is no changes, or increase in the bottom line of the budget.

Trustee Payton responded that the Village Board has no power to raise rates for Aqua Water Company, this can only be done by the Illinois Commerce Commission.

Mayor Covington responded that she does not talk about anyone.

Mrs. Sonja Jenkins voiced her concerns with attempts to silence certain groups or individuals and asked the Board to explain what they feel freedom of speech means.

Trustee Williams responded that she feels freedom of speech means that one is able to say whatever they want.

Trustee Wilson responded that one should be able to say what you think, however social media has guideline for what is posted on social media sites. She also stated that she had nothing to do with people being removed from Nextdoor, and that she did not start the next door social media.

Trustee Brooks responded that freedom of speech allows one to say whatever they want to as long as it is not in a threatening manner, or an act of disorderly conduct, and that he believes in First Amendment Rights.

Trustee Brown responded and explained the laws of social media and commented on limited public forum when monitored. He stated that Trustee Wilson had him kicked off of next-door without explanation.

Mayor Covington asked Trustee Wilson to confirm that Nextdoor started as a communication tool in the Fairway Estates where she lives.

Ms. Deborah Stroud thanked Public Works Director Richardson and his staff for the snow removal, and the rapid response to fixing the streetlights on Amherst. She offered her condolences to the Barnett and Brookins family in the loss of Gloria Barnett Brookins.

G. Reports of the Mayor, Board of Trustees, Clerk, Manager, Appointed Officials, And Committees\Commissions

G-1: Reports Of IRH

IRH Development's Senior VP Lamar Rogers apologized to the Board and residents for His behavior at the February 13th meeting. He gave an update on the status of the work: That IRH has done which includes the following: completed several portions of the documentation required for the upcoming audit. This included several cash accounts and analysis of Fixed Assets in the Golf Club Fund, the Town Center Funds as well as the Governmental Assets Village-wide;

Reports Of IRH - continued:

IRH received and reviewed TIF Reimbursements requests and expenditures from Exeter, WP Carey, Clorox documentation IRH; working on reconciliation of Payroll cash for May, 2015 through April 2016 is in the process of being completed. Reconciling items that have been posted to Fund Balance; reconciled FY 2016 (May 2015 – April 2016). IRH has reconciled Golf Club FY 2016 (May 2015 – April 2016) This included identifying a sizeable number of reconciling items for each month that will need to be corrected in the General Ledger. Relating to the Forensic Audit he stated that the final summary and detailed schedule are being prepared to conclude, and is expected to be completed by March 6, 2018.

Reports Of Appointed Officials

Village Treasurer Dilworth stated that spending money for training without knowing the financial status of the Village is inappropriate.

Report Of Village Manager

Village Manager Pate reported that he is working on the new budget, and stated that he would like to present a clear budget, and asked the Board if any members see where there can be employee cuts to please let him know. He also stated that in the restructuring process he will be taking certain departments under the office of the Village Manager; the new Village Auditor is looking into a new budget system; relating to usage of 90 Town Center Drive, he stated that he has no knowledge of what rentals were used for, and if he is expected to restrict Trustee's use of the facility he feels it would put him in a subordinate atmosphere, and feels that the Board should pass legislation, or put the directive in writing. He further stated that he feels usage of the facility by the same group consistently should be charged a minimal fee.

Reports Of Board of Trustees

Trustee Wilson commented on the many shootings and gun violence in the country and reported that the League of Women Voters is urging everyone to contact their state Senators are representatives and support the Lethal Violence Order Of Protection (LVOP) which is SB 559 and HB 2354. She noted that this bill empowers family members who are concerned about a loved one hurting themselves or others to petition the courts to remove firearms. Contact information for your state legislators is located at http://openstates.org/find_your_legislator/. She also reported that the Chicago lawyers committee for civil rights education equity project would present an SOS Parents Information Meeting on March 10, 2018 at the University Park Library District.

Report Of The Village Clerk

Village Clerk Dee Jones reported that early and absentee voting is currently in process, and since early voting is no longer available in University Park, residents of University Park should contact the Will County Clerk's Office at 815-740-4816 to ascertain a location where they could vote early. She also noted that residents can cast absentee ballots by contacting the Will County Clerk's Office.

The entire Board of Trustees, Mayor and Village Clerk offered their sincere condolences to the family of Mrs. Gloria Barnett Brookins who passed away earlier today.

Report Of The Mayor

Mayor Covington reported on meetings and events she has attended and participated in since the last meeting, and submitted the following report to the Clerk for inclusion in the minutes: Sorry Sad to hear about Ms. Gloria Barrette Brookings. Condolence and prayers are to the family; At the SSMMA Transportation meeting she spoke with the Metra, and letters were sent from her and by SSMMA President of the Transportation committee. I sent them my concerns along with photos that I had and some that were submitted from Trustee Curtis McMullan and Resident Diane Humes; I am happy to hear that the ROTC program is now in the process of merging with another school to bring it back to CMHS. I made a request when my daughter was in high school and once Dr. Hall became a Board member and later the President of the school Board she took full charge of perusing this effort. She stated it has been ten years to get it to this point. Congratulations. Look forward to seeing it to the full succession.

The Board will have a retreat shortly we are striving for March. We are also looking forward to a workshop on the Bus service once I get concurrence from the entire Board. We are looking for participants for the Village seal and Village sticker project. Congratulations to Southland College Prep School in Richton Park for their ground breaking today.
